ALPINE MARINA BOATER HANG TAG INSTRUCTIONS

Boaters who rent a slip at Alpine Marina and whose name appears on the marina operator provided tenant log may apply directly with the Palisades Interstate Park Commission to receive up to two free hangtags per slip.

Hangtags allow boaters to 1) use designated boater parking spaces located in the eastern section of the Alpine Picnic Area parking lot, 2) be in the park before and/or after hours, 3) keep their vehicle(s) in the park overnight, 4) have limited access to the marina during road closures. Please note that access during road closures is at the discretion of park staff.

To receive up to two free hangtags boaters must complete the accompanying application, and provide the Commission with the following documents:

- Boat Insurance: Boater's name must appear on insurance. If the vessel is insured under a company name, then supporting documentation, *such as a business card listing the boater's first and last name* must be provided, thus linking the boater to the company.
- Boat Registration or Certificate of Documentation
- Boater's driver's license
- Boater's vehicle registration (2 separate vehicle registrations for 2 hangtags)
- Above listed documents must be valid at time of application

Boaters may use the accompanying application to purchase up to two additional hangtags (*at \$75.00 each*) per slip for their friends and/or family directly from Palisades Interstate Park Commission. The name of the friends and/or family members must be listed in the marina operator provided tenant log. See instructions on the accompanying application.

BLUETOOTH ENABLED LOCK

The Palisades Interstate Parkway Police are conducting a pilot program "Smartlock" that will allow a limited number of participants access to the Alpine gates via a smartphone and Bluetooth-enabled lock. The goal of the program is to eliminate the J key currently needed to access the boater lock at the Alpine gate. If you would like to participate in this pilot program, please complete the information below. Once accepted you will receive a link and credentials to the teleport app.

Boaters will be notified by email from parking@njpalisades.org when their hangtags are ready for pick up at the Palisades Interstate Parkway Police Headquarters on Alpine Approach Road in Alpine, New Jersey.

PLEASE FAMILIARIZE YOURSELF WITH THE FOLLOWING CONDITIONS:

- Hangtags must hang from the rearview mirror and must be always visible
- Metered parking fees apply outside of designated boater parking areas
- Failure to display hang tags while parking in designated boater parking spaces may result in issuance of summonses or fines
- Hang tags are transferable
- Hang tags are needed to gain access to the park outside regular operating hours
